

## PRIVACY STATEMENT

This is a privacy statement of Utrechtse Studenten Volleybalvereniging Protos (hereinafter referred to as USV Protos), located in Utrecht and registered with the Kamer van Koophandel under number 40480098. This privacy statement describes which personal data we process, for what purposes these personal data are used, and the measures we have taken to ensure that the processing is lawful, fair, and transparent in accordance with the requirements of the General Data Protection Regulation (Algemene Verordening Gegevensbescherming).

### 1. USE OF PERSONAL DATA

1.1 We (may) process the following personal data from you if you:

- (h) Gender
- (i) Registration date
- (j) Volleyball association number

1.3 We may use this data for the following purposes:

- (a) To effectuate the membership
- (b) To send newsletters
- (c) To contact or communicate with you
- (d) To improve the service
- (e) To fulfill the contract with the association
